have their assets in hard currencies, or fixed assets like properties, equipment, buildings and / or lands.

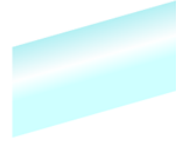
Workers and small merchants are harmed by fiscal voracity. Inflation is the tax that affects on the poorest, and finally involves the society entirely, because markets fall down.
