

## TERRORISM

Along the present article, in a passionless way, we will examine modalities, origins, and links of terrorism; starting with a classification based on motivations of diverse groups.

### 1) CLAIMS

1.1) Territorial: ethnic or religious Minorities that once had own territory, or some type of autonomy, or they hope to have it, and secessionist movements.

1.2) Political: Groups that fight to break the continuity of certain government type, the hegemony of a social class, or ethnic group, and the anticolonialist movements.

### 2) ENLIGHTENED VANGUARD:

Groups with ideology: they consider that their thinking should dominate, and that their world's conception, is the only one correct. Their points of view do not coincide with the Western Christian Civilization.

### 3) STATE TERRORISM:

3.1) In War: it is to mine the enemy's resistance, of weakening their cohesion, of achieving divisions among the country's inhabitants.

3.2) In Peace: Habitually it is about geopolitical strategies, to weaken the countries they wish to attack, or to weaken countries, they think could attack them, to avoid it.

Habitually they give support to groups with "claims" (1) inside the country they consider as enemy.

3.3) On the own population: Strategies to maintain the government, to assure the continuity in the government of a social class, ethnic group, or to motivate the population for a war.

### 4) RELIGIOUS FUNDAMENTALISM:

They are convinced that, their war is in support of their divinity, that they possess a legacy, where their god ordered them to behave in certain way, which will lead them to rule the world.

We go now to attempt a classification based on their fight methods, and the progression wanted by them until achieving the complete dominance:

a) INFILTRATION: it is concretely to pass over the frontier line, pretending to be part of the faction to attack.

b) PROPAGANDA:

b.1) From the infiltration: it is hidden until being able to settle down like an option for the infiltrated population. Once established in public opinion, it not worth to be hidden.

b.2) From the own faction: They pretends to have a high level of life, and the obtained achievements are magnified. They hide their difficulties.

c) Subversion:

c.1) From the infiltration: leaders, and cells; recruitment, and training.

c.2) From the own faction: support to claims groups (1). This support could be; financial, provision of weaponry, training camps, logistics, joint ventures.

d) TERROR:

d.1) From the infiltration:

d.1.1 Sabotage.

d.1.2 Conformation and / or economic support to groups that publicly declare their opposition to the policies of the government, in the infiltrated country.

d.2) From the own faction:

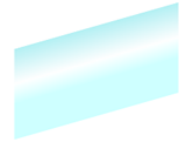
d.2.1 Training and sending of sabotage groups.

d.2.2 Threats of massive attacks.

e) GUERRILLA: The subversive group has established a beachhead. It dominates a territory portion. It is gathering forces to dominate.

Let us attempt another classification, this time for the level of danger, in decreasingly order.

A) RELIGIOUS FUNDAMENTALISM Everything can be expected from them; massive suicides, suicidal attack, geopolitical movements, infiltrations, propaganda.



We could unite in a single thread, Albigensians, "reverend" Jim Jones and Jihad.

We grant them the maximum degrees of danger, because they feel, themselves are located above the humanity.

Any life is worthless for them, that are the executioners of the divinity plan for the human race, and whose prospective salary is the paradise.

#### B) ENLIGHTENED VANGUARD:

They Share with religious fundamentalism the scorn for human life.

They think that are located in a superior level than humanity, and considered themselves as humanity's saviors.

Their danger resides in their fully conviction that any human sacrifice is minuscule, compared with the benefit to obtain for the whole humanity with the implementation of their social theory.

In this definition, we can put side-to-side Jacobins and Communism.

#### C) TERRORISM OF STATE:

C.1) Mass Destruction Weapons (MDW) Proliferation.

C.2) Global financing of terrorist groups.

C.3) Open market financial games:

C.3.1 Purchasing of, third countries' valuable companies and banks, by mean of subsidiaries or figureheads.

C.3.2 Stock exchange and monetary market destabilization trough sudden purchases and sells.

C.4) Third faction's terrorist groups training.

C.5) Espionage, mainly in technology, military and industrial area.

C.6) Support to drug dealers. Alliances, exchange of favors.

C.7) Threats about the use of massive destruction weapons in urban centers.

#### D) CLAIMS GROUPS:

They can be considered the less dangerous ones, if they maintain the conflict at local level.

We do not want to qualify as terrorist the anticolonialist movements, which fight against the oppression with conventional methods, neither can we accept such arguments as "holy war" or "fair war."

Terrorism makes non-sacred and unjust all wars.

The conductive thread among all these groups, for which they are included in this article, is their aggressive methodology, which always exhibits the highest disdain for the human life.

Their absolute contempt for human life possesses several modalities, which are necessary to declare:

a) Their extreme ideologized behavior, based upon brain washing and mental conditioning tactics, to motivate the terrorists to accomplish their tasks, even if it includes suicidal actions.

This declaration comprises the suicidal terrorists "bought" with promises of money for their families, and paradise for them.

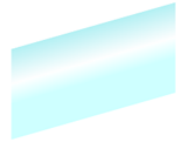
b) Target choice; for the terrorists we all are an appropriate target. For them does not care children, women, or simply civil unarmed. They do not make any distinction among soldiers and civilians.

c) They work towards the deepening of the rift: The twin towers, the attack to the subway of Tokyo with sarin gas, the Israeli Club blasting in Buenos Aires. It seemed that each terrorist organization uses all its financial, human and logistical resources, to maximize the damage.

If the objective is to intimidate, it had been enough with filling the Tokyo's subway with a visible, colored and breathable gas; to place in, roar bombs, in some levels in the twin towers, or to blast at night, the Israeli social club of Buenos Aires, when there are not, almost, employees that can be damaged.

In each attack, terrorists foment hate. Not only of their followers to us; but also of all of us, toward the terrorists, by their attacks' brutality and the great quantity of innocent people harmed.

In war, there is a golden rule: to defeat the enemy harming him the little as possible, since when finishing war, all fighters should get ready to seat together, to agree the terms of the peace coexistence.



On the contrary, terrorists, continually, harm as much as they could, inhibiting themselves of participating in any future armistice.

There is a dramatic circumstance on fundamentalists' behavior. Their aim is to do the biggest damage, in the most terrifying, and abhorrent form that they can do.

They want to horrify us in such a way that our answer could be a large-scale attack against all the Muslims of the whole region in conflict, or even, on the Muslims from all over the world. However, we are not their dummies at all.

They want to use us as agglutinative element of whom they consider their nation.

Does not interest them the eventual serious damage the Muslims would suffer.

Their scorn for the life of their coreligionists is also absolute, since they think; they are carrying out their god's plan.

#### A LAST QUESTION

Why terrorist groups with dissimilar beliefs, and sometimes, with opposed ideology, from the entire world have shared tasks?

Sometimes it is about financial maneuvers; training, in exchange for monetary support, Weaponry supply for cash, or logistics.

However, *it is anything but of attacking the enemy, all the non-terrorists, us, from all the possible fronts.*
